

II 23 May 18: FIS Group has reached a deal to acquire North

Carolina-based Piedmont Investment Advisors. The combined company will manage more than USD 10 billion in assets when the deal closes during the third quarter of 2018. This is the first acquisition for FIS, which is based in Philadelphia and specializes in Global Small-Cap strategies. The firms have little overlap in product offerings: FIS invests in Global Small-Cap strategies in capacity strained areas, while Piedmont offers Active, Passive, and Structured-Beta Equity strategies, as well as Core Fixed Income management. The combination of FIS, which manages USD 5.6 billion in assets as of April 30 2018, and Piedmont, which has USD 4.7 billion under management, will give the resulting firm more than USD 10 billion in assets. Following the merger, Piedmont will operate as a fully-owned subsidiary of FIS. Williams will be the Chief Executive Officer of the combined companies, and will continue to work as FIS' Chief Investment Officer. Isaac Green will remain as President and Chief Investment Officer of Piedmont, which will continue to operate in Durham, North Carolina.

Marie-Pierre Peillon, Head of ESG Research & Strategy IE 23 May 18: Peillon has been appointed as Head of Environmental, Social and Governance Research and Strategy. She was formerly Head of Research. In 2000, she was responsible for developing the Credit and Equity research unit of Groupama Asset Management.

Asiaasset 23 May 18: Maybank Asset Management Group (MAMG) says its 51 million ringgit (USD12.83 million) acquisitions of Kuala Lumpur-based Amanah Mutual and Singapore Unit Trust Ltd (SUTL) have been completed after receiving regulatory approvals. MAMG, a wholly-owned subsidiary of Malaysia's largest lender, Malayan Banking (Maybank), also announced the promotion of Badrul Hisyam Abu Bakar as its new Chief Executive Officer, responsible for overseeing Maybank's regional asset management business. The company acquired AMB for 16.12 million ringgit and SUTL for 34.88 million ringgit from Permodalan Nasional, Malaysia's largest fund manager. Mr. Badrul was formerly Head of MAMG's Malaysian Operations, which he joined as Chief Investment Officer in 2010. He became its CEO in 2014. That position has now been filled by Ahmad Najib Nazlan, who was formerly the CEO of Maybank's Islamic asset management subsidiary.


